Contract conditions:

- The deposit must be paid between 12 and February 21, 2021. This is after the first check by the vet at 9 weeks. Payment information: IBAN NL28INGB0005707966 SWIFT / BIC INGBNL2A.
- 2. The rest of the payment (€1.000) must be paid before March 20, 2021. The payment must be transferred to bank account IBAN NL28INGB0005707966 SWIFT / BIC INGBNL2A.
- 3. If the buyer decides not to buy the cat, the deposit is non refundable.
- 4. The buyer agrees to collect the kitten on 29 March 2021. If no other appointment has been made and the buyer does not collect the cat within the specified date, the breeder has the right to sell the cat to a new buyer. The depotis is non refundable.
- The buyer arranges the transport of the kitten from the breeders' address to the buyer's adress (Cattery Perla Annura). The buyer is responsible for transport and transport costs.
- 6. The breeder has the right to cancel the agreement without giving a reason. The breeder will refund the received amount from the buyer within 7 days of the withdrawal date.
- 7. In the event of a kitten's illness preventing it from being issued to the buyer or the cat's death, the buyer will receive a refund within 10 days.

Warrenty:

- The breeder declares that the kitten is in good health on the day of purchase and departure. The kitten is vaccinated (incl.rabiës), wormed and provided with a datachip. Kitten is in possession of one upon departure EU passport, pedigree and ontract.
- The breeder cannot be held responsible in case of veterinarian cost, accidents, illness or injuries to the cat (Sibia Ana) from the moment the transporter has collected her from the selling breeder in Leiden, the Netherlands. The buyer declares by signing this contract that cat Sibia Ana shows no signs of illness before she is placed in the transport car and the buyer is liable from the moment the kitten leaves the breeder's door (moved).
- The breeder guarantees that the cat is not a carrier of hereditary diseases for which the parents have been tested. For information about testing. (see copy our website).
- The buyer is entitled to a new cat for € 650 (excl. transport costs), if it appears that the cat has a (genetic) hereditary defect or (genetic) hereditary disease. The buyer will receive the new cat, provided the cat has not previously been used for breeding and after the breeder has received the following written items within 14 days from an independent specialist.
 - test results vet/specialist
 - scan vet/specialist
 - photo's vet/specialist
- castration bill of the kitten off "Cattery MC'B Coons Sibia Ana".

There are no show, breeding, or development guarantees.

Buyer's obligations:

- Buyer declares by signing this contract that he complies with the breeding Terms and Conditions.
- 2. The buyer is responsible for the cat's breeding program, care and love for her.
- 3. The buyer declares by signing, that the cat is only used for breeding in her own Cattery Perla Annura Poland.
- 4. When the buyer is going to relocate the cat, it will first be neutered. The cat Will never go to an animal shelter.

Contractual:

If the buyer does not follow the Terms and Conditions in the contract, the buyer will pay a penalty to the breeder of € 2500. By any legal event Dutch law is applicable.

The buyer has read and understands the Terms and Conditions of this contract and agrees by signing the contract in duplicatie. Buyer signs every page at the bottom right of the contract.
